**Great News!** Paola, USD #368 has partnered with the Friendly Smiles Program through the Douglas County Dental Clinic to offer **FREE** in-school dental care. If your child does not see a dentist regularly or you are looking for a new dentist, simply fill out a consent form. Clinics are scheduled as follows for USD #368 schools.

## Dental Clinic Dates:

**Cottonwood Elementary School--March 10**

**Sunflower Elementary School--March 12**

**Paola Middle School--April 1**

**Paola High School--March 12**

## Deadline to Enroll: February 24th

Friendly Smiles accepts Medicaid, Commercial Insurance, and the uninsured. There is **NO COST** to you even if your child is uninsured or not fully covered through commercial insurance. Uninsured students must qualify for free and reduced lunch to participate in our program. Direct dental services provided to your child while in school is completely **FREE**.

Having your child seen by the in-school dentist saves you valuable time, as well as less time taken from your child's academics. Top quality care is provided by a licensed dentist and hygienist right in the familiar surroundings of your child's school. Dental care includes a complete exam, x-rays, cleaning, fluoride, sealants, restorative care such as fillings, and when needed baby tooth extractions. You may opt out of specific services.

By having your child see the in-school dentist, you can help reduce the risk of:

- Dental Decay
- Early Tooth Loss caused by dental decay
- Gum Disease
